OUR APPROACH/SERVICES MODEL

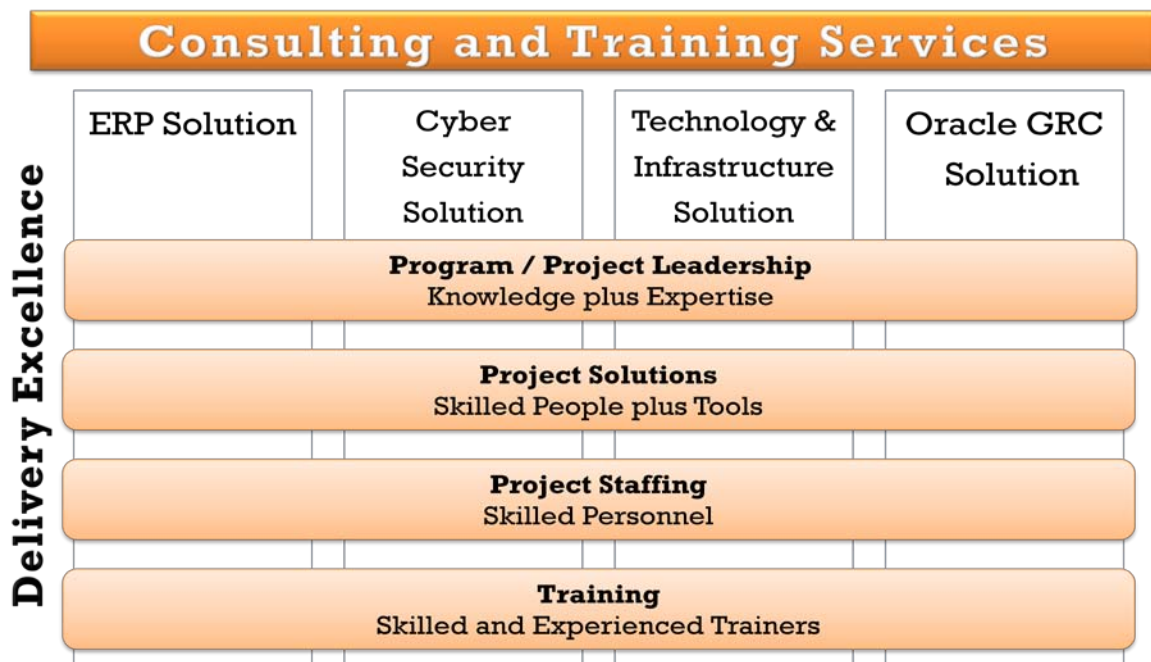

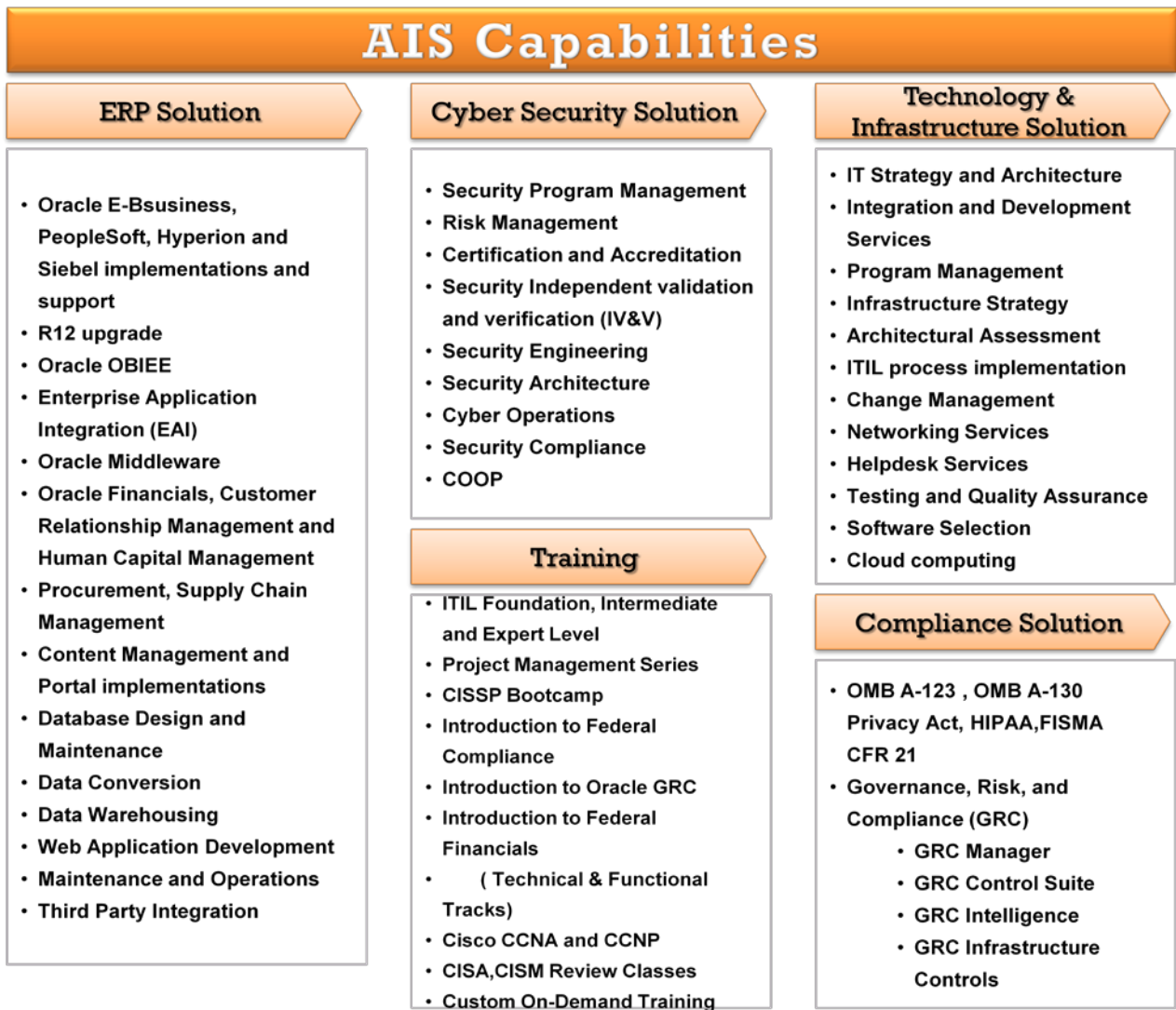
